SARATOGA SENIOR Center

The Saratoga Senior Center has seen unprecedented growth over the past 15 years reflecting these challenges - most noticeably in the last few years. Since 2021, membership rose 66% to 2,700, with total seniors served increasing 35% to 3,700. After relocating to the Saratoga YMCA campus in fall of 2023, we've welcomed 1,100+ new members, nearly doubling daily foot traffic and filling classes to capacity. Our weekly food distribution program grew from 125 to 240 bags, with over half now home-delivered, indicating rising need from homebound and rural seniors.

This historic growth demonstrates both the critical demand for our services and our challenges meeting it. With your generosity, we can connect seniors with compassionate volunteers who offer transportation, food assistance, companionship and support. We help them navigate systematic and medical difficulties and provide aging in place services. Our social activities and health and wellness programs all foster a sense of belonging. Together, we can create a thriving community where seniors not only access resources but also build meaningful connections.
